

Regular Maintenance

SPRING Cooling Inspection

- ☐ Check for adequate refrigerant charge
- ☐ Check operating pressures and temperatures
- ☐ Check electrical connections
- ☐ Check condition of evaporator and condenser coils
- ☐ Check belts and pulleys
- ☐ Check proper drainage of condensation
- ☐ Check calibration and operation of thermostat
- ☐ Check contactor, capacitors, and relays
- ☐ Check total performance and efficiency of the cooling system
- ☐ Clean, lubricate, adjust, repair, or replace any components wherever necessary

FALL Heating Inspection

- ☐ Check calibration and operation of thermostat
- ☐ Check gas valve and pilot assembly
- ☐ Check all safety controls
- ☐ Check for gas and flue leaks
- ☐ Check belts and pulleys
- ☐ Check burners, fan limit, and fan controls
- ☐ Check total performance, operating efficiency, and safety of heating system
- ☐ Clean, lubricate, adjust, repair, or replace any components wherever necessary

- ☐ **Filters**—Are they clean?

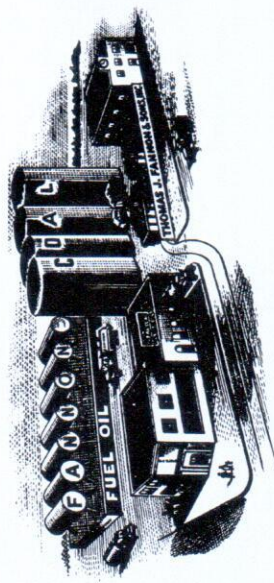

Premium Service Plans

Gas Heating and Electric Cooling.....	\$329.50
Heat Pump.....	\$329.50
Heat Pump with Furnace.....	\$399.50
Heating Only or Cooling Only ..	\$229.50

Prices reflect coverage for one furnace or boiler and/or one air conditioner. Multiple units will be subject to an additional charge. Some units accessed by ladder may not be covered.

Equipment to be covered for the first time must pass Fannon inspection. Only equipment installed by Fannon will be eligible for Premium Coverage.

All of these parts will be repaired or replaced as required, labor included:

Labor warranty applies to work performed during weekday operations (Monday–Friday, 8:00 am to 4:00 pm). Evening, weekend, and holiday service calls covered under plan are subject to a \$50.00 service charge.

R22 refrigerant will no longer be covered.

Compressors, heat exchangers, coils, filters, zone valves, automatic dampers, electronic air filters, humidifiers, chronotherms, condensate pumps, aluminum condensers, and other accessories are not included in this agreement except as specifically stated. A labor charge will be assessed when heat exchangers, compressors, coils, or other equipment covered by manufacturers' warranties are repaired or replaced.

Services not itemized above such as repairs to plumbing portion of system (circulator assemblies, expansion tanks, motorized valves, pressure relief valves, radiators), electronic air filters, and humidifiers, and calls for switches accidentally turned off by customer, are charged on a Time and Material Basis. Water damage to controls resulting from condensation leaks or air conditioner freeze-ups may not be covered under this plan.

Condensing Boilers

Manufacturers of modern, high efficiency condensing boilers recommend a precise maintenance program in order to ensure a longer life and reliable performance of the equipment. This labor intensive process includes the replacement of gaskets and condensate neutralizing chemicals. Seasonal maintenance cost on condensing boilers is as follows:

- * With Premium Gas Heating Contract **ADD: \$300.00**
- * Annual Maintenance Cost with No Contract **\$600.00**

Steam Boilers

Steam boilers require a unique maintenance regimen which includes a flushing of the boiler, breakdown and cleaning of the water feeder and pressure controls, and the addition of chemical agents to maintain clean steam pipes and prevent blockage. Maintenance cost of steam boilers is as follows:

- * With Premium Gas Heating Contract **ADD: \$100.00**
- * Annual Maintenance Cost with No Contract **\$350.00**

Service calls which are not covered by contract:

Standard charge weekdays until 5:00 pm \$150/hr
 Standard charge Saturdays, holidays,
 and after 5:00 pm. \$195/hr

We recommend that inspections be scheduled during milder temperatures. In times of extreme conditions, we cannot guarantee availability for seasonal maintenance. While we make every effort to inspect equipment yearly, it is the customer's responsibility to schedule inspections.

This contract runs May 1st to May 1st and will renew automatically.

General Conditions

- T.J. Fannon & Sons, Inc. reserves the right to reject any agreement if, in an inspection by our service technician, the equipment is found in such condition that service will be unsatisfactory to both parties.
- A service plan will not be continued when it is found that working conditions are hazardous or unsanitary.
- Our responsibility under all circumstances is limited to the direct cost of correcting any defective condition covered under a service plan.
- This agreement does not cover balancing of heating or cooling to various rooms, nor does it include improvement to the present systems.
- It is mutually agreed that this agreement covers only electrically-operated units inside the equipment and does not cover electrical or plumbing work beyond the units, or work required due to negligence or misuse of equipment or because of fire, flood, or other water damage from humidifiers or other appliances, acts of God, sabotage, shortage of electrical, gas, or water supply, or damage caused by freezing.
- The obligation to furnish replacement parts is subject to availability at local suppliers. The substitution and/or reconfiguration of new parts and controls in place of obsolete parts on older equipment will be subject to a charge for labor and materials.
- Freeze-ups in vacant properties are the sole responsibility of the owner. Vacant buildings are not covered for parts or labor to correct any conditions caused or aggravated because of non-occupancy.
- The terms and conditions of this agreement, dated May 1, 2019, supersede any and all previous service agreements offered by T.J. Fannon & Sons, Inc.
